CHAPTER ONE

INTRODUCTION

A. THE BACKGROUND OF STUDY

The mission of Prophets with whole of the nobles characters from Prophet Adam till the last Prophet Muhammad Saw for the highest purpose. This showed the biggest urgent to renew a mankind life. Tawhid is principle mission and the highest duty from the Prophet to deliver the messages to the mankind which written within Al Qur'an:

"And We did not send any Massenger before you (Muhammad Saw) but We revealed to him (saying): *Laa ilaha illa Ana* (none has the right to be whorshipped but I (Allah), so worship Me (Alone and none else)"¹

Tawhid is justifiying God Allah's existence, His oneness and all of His perfect characters which Islam pressed specifically to belief to Allah to grow our belief to Allah and to be more devout to Allah. There are seven things which are essential for muslim to believe in. These come under the heading of *Iman Mufassal*, which requires a longer, more detailed declaration of faith. They are to believe in Allah, in His angels, His revealed Book to all of His messengers, in the Last Day (the Day of Judgment), in *Taqdir* (the doctrine of predestination, which means that everything good or bad is decided by Allah), and in Life After Death.

Islam as religion which filled by the rules had been given a chance and dispensation to its adherent to perform many activities to prove his confession about God existence with the variety of pious deed as shodaqoh, helping the orphans, weakmen to perform the praying etc. Those deeds as particular measurement to measure that someone confessed that he is Moslem who belief in six pillars of faith which realized by performing the particular pious which found in Islamic Pillars viz syahadat, praying, fasting, zakat and pilgrimage.

Islamic Pillar as a religion is a right belief, a consistence belief between statement and oral by the reality that showed by the deeds. A milestone of belief is belief in the existence of the truth, which must be conversed, viz the truth of God and what He wants. That belief showed by *syahadat* ³:

" I testify there is no God but Allah and Muhammad is His Prophet"

It is not only an oral statement but also showed by the deeds, as praying, which is mean of communication from a slave to his creator who gives a chance to proof his belief that Allah as a creator with whole of perfect characters and his love's feeling to his God.

Every muslim testifies that praying is being the cornerstone of religion, for he knows in his heart that it is the most important pillar of the faith. Indeed, it is the factor which differentiate muslim from non muslim. As such it is of Supreme value to Allah. The Prophet said that on the Day of Judgment the first thing that the servant of Allah would be called to account for would be prayer. If he had

Prayer is an individual duty incumbent on every muslim man or woman over the age of puberty who have heard the message of the Prophet Muhammad (peace be upon him), and being of sound mind clean, are capable of performing it. A child is requires to perform the prayer from the age of seven, so that, he or she will be brought up to love it and make a habit of it. If by the age of ten he has not yet developed the habit of prayer, he must then be constrained to perform this religious duty.

Actually, only vision from God to man can make them to be faithful. To grow and to strong the vision from God, the human have to learn. Therefore in this boarding school learned Tawhid Lesson in order that students have strong faith and conviction solidly within six fundamental principal of faith realized by performing particular pious which fond in Islamic Pillars.

We referred earlier to an Islamic system of order and discipline. Islam itself is the epitome of the Divine cosmic order and discipline, and the man is conscious of his destiny in Islam knows that in like manner too is an order and discipline, in that he is like a city, a kingdom in miniature; for in him as in all mankind, is manifested the Attributes of the Creator without the reverse being the case.

Therefore, the researcher tries to know how far the awareness of class six student of KMI Pondok Modern Gontor For Girls I within praying performances included its disciplines and rules which used especially the obligated of five times

to pray together in the mosque. By knowledge which they got, religion's condition and the good space which support praying performances especially congregation prayer. So in the congregational praying expected to class six student of KMI Pondok Modern Darussalam Gontor For Girls I filled with awareness as senior students in the boarding school who got tawhid lesson within four up to six years.

B. THE FORMULATION OF STUDY

With the formentimed background the researcher wishes to formulate a problems which appeared and needed to be studied as follow

- 1) Did the student perfom the congregational prayer conciously?
- 2) What was the influences of tawhid lesson to the quality of their praying?

C. PURPOSE OF STUDY

Discipline is loyality to the rules.⁶ And the mean of **prayer's disciplines** which researcher intented is soul and practice it purposed that all of his deeds to adhere the rules and dicipline which concerned with praying.

The discipline prayer is discipline which obligate to pray congregation in the mosque for all students by established time as the times of prayer.

Class six students of KMI is all students or pupils of class six students of KMI Gontor for Girls 1 in academic year 2003 amounted to 364 students. KMI Gontor for Girls is the Educational Institut in same level of Senior High School and it is situated at Sambirejo Mantingan Ngawi East Java.
