Chapter One

Introduction

A. Background

After multi dimension crises run into Indonesia, the Indonesian lost their confidence and need morals and spirituals supports for their life¹

The attendance of the capable preachers who handle their fidgets and diminish their restless life be waited. Because the preachers are there at time not performing their da'wah and it just became a part of their second activities. The da'wah materials which they delivered are also monotone. It caused da'wah activities give no real contribution to the umma'. More than those above, that the activities of da'wah give in a very narrow meaning. They just deliver theoritically Allah's messages. Which are not followed by practical activities. ²

The great thing left by them are planning, organizing, actuating and controlling even evaluating in their da'wah for method of da'wah they utilize speech method or one way communication and rarely use dialog method or two-ways communications ³ and they make no real sample in their daily life. Or what they say are contrary to all their daily life activities so their words of da'wah have no power.

In such wrost condition of da'wah, Aa Gym (K.H. Abdullah Gymnastiar) a da'i who has spesific feature in his da'wah came into being.

His da'wah characteristics are comfortable, popular, practicable, powerful, full of enchantement, pasionate - eassy to be absorbed by all society. The sentences are quivered the hearts⁴

Aa Gym's da'wah spread largely among the community life at large. Many evidences found that Aa Gym da'wah gives some influence to them, because Aa Gym did not halt in only but he supported his audiences to perform their comprehensions⁵

Some real acknowledgement from members of communities about the influences of Aa Gym's da'wah toward their religiousity expressed by Prof.Dr. Yunan Yusuf it give the real contributions in his religious spirit.⁶

Aa Gym. i.e: Begin from the simple thing, Begin from your self, Begin as early as possible.

"I felt more patient than before, and I'm not so eassy to be jealous again to my office mates who one level with me but they got more salaries than me ⁹

Beside that there was another acknowledgement which expressed by Baihaqi 17 years, a student of class 3 of Natural sciences of 5 Senior High School in Surabaya.

"His reflection added us more sciences and aware us from our stupidity, also remind us about our attitude and our conduct." He said.

And because of Aa Gym da'wah Baihaqi tries to improve. This determined will appeared after he listened Aa Gym da'wah in Surabaya on last July 2002. 10

Based on the explanation above there was an academic restless had growth highly in the writer's mind. And it caused a great will to conduct research this reality scientifically. This research also was in the form of comparative religion's field because dakwah activity was one of religious activity.

C.Limitation of Study

Based on the explanation above the writer tries to find out some problems, which may be limited as follow:

- The influence of Aa Gym da'wah towards the rituals of the teachers of Pondok Modern Gonter II.
- The Influence of Aa Gym da'wah towards the Practice of Islamic Religious obligations.

D. Formulation of Problem

E. Purpose of Research

F. Assumption and Hypothesis

G. The Use of Research

H. Metodology of Research

This study analyzes the influence of Aa Gym da'wah toward attitude of religius changes of the teachers of Pondok Modern Gontor II, it is a kind of Descriptive Qualitative Research, then the writer in this study utilize Descriptive Method. And to do this research the writer should formulate it as below:

1. Design of research.

In this research the writer uses Psychological Approach, where the data of it got by qualitative research.

2. Population of Sample

The population of this research is all the teachers of Gontor II who like Aa Gym da'wah. The amount of them are 7 persons. There are two kinds in sampling Metode; Random Sampling and Purposive Sampling. In this research the writer uses the second method i.e. Purposive sampling that the teacher who like Aa Gym da'wah only. Criterias of like is that: the respondents listen and read Aa Gym actively, some of them have the articles of Aa Gym da'wah and utilize them actively or they borrow these articles from their friends and use them actively.

3. Kind of Source of Data

There Are two kinds of data in this research, they are:

a.Primary data, it source is the teacher of Pondok Modern Darussalam Gontor II.
b.Secondary data, its source is Aa Gym books, his cassettes and other Aa Gym writings or writing about Aa Gym in many kind of mass media and also the result of another research which have the same kind with this research.

4. Method of collecting data

In collecting data, the writer uses interview method, by holding a conversation with them. This conversation is guided by an interview guide. The form of inteview Guide which the writer uses is "Semi Structured" in this method the interviewer ask some Questions which had structured, then one by one were deepen to get more informations ¹⁵

4. Technic of analyzing data.

In analyzing data the writer uses descriptive analyzes, this technique analyzes the quality of data with descriptive presentation¹⁶
