CHAPTER ONE

INTRODUCTION

A. Background of Study

The Prophets are the best of mankind in which Allah gives His favors to carry out this message. They are chosen as the intermediary of the Divine speech to His people, who are given special revelation and knowledge to guide His people on the right path.¹The privileges that the prophets acquired were not an ordinary matter, they were believed to have the inspiration and revelation passed down directly from God to be communicated to their people.² Therefore, the inspiration and revelation obtained made it easy for the Prophet to convey a message to His people.

In the spread of a sermon, there are events that are often considered impossible to be obtained in this modern era, the example as the gift of prophecy. Prophecy is a prediction or a divination, which means a prediction about future events.³ Whatever is done both words and deeds is a role model for His people. Thus the prophet can continue the teaching and practicum for the life of the people afterward.

However, in the regard of the prophet's teaching was raised concerning the claim about the inspirations and visions that's Prophet received is a falsehood and had come from Satan not from God.⁴ While in the Qur'an the letter of Asy-Syuura explains that Allah conveys revelation through the angel Gabriel by entering the revelation in his heart.⁵ Therefore,

this has created a lot of disagreements between people who believe in it and make them do historical research to get an inspiration.

As a manifestation of the influence of these claims, there arose false prophets who came at the end of time and claimed to have prophecies.⁶ Moreover, the prophecy or the word of a prophet of things to come should not pass the Scriptures he carries. Because the fact shows that the true prophecy of a prophet never contradicts the Word of God.⁷ Therefore the vision of the prophet must be true from God and delivered to his followers.

Begin from the meaning of Prophecy, when it has examined in the concept of Adventist Church teaching by Ellen G. White. There is an issue with the origin of prophecy in Adventist. Due to an important event ever experienced Ellen White in her ninth year. She suffered severe injuries because of the behavior of a girl who did not like her. Eventually, her nose is permanently damaged and possibly a concussion. The impact of the event, causing her to often experience excessive fainting and convulsions.⁸ Her childhood is no longer perfect, unable to go to school and meet her peers.

Responding to the emergence of the phenomenon, as Molleurus Couperus argues, a retired dermatologist accuses Ellen White of the vision of a prophet is caused by some "form of epilepsy".⁹ So that the prophecy obtained is no longer from God, but a brain error that works beyond reason.

The assumption reinforces aSeventh-day Adventist theologian, Samuele Bacchiocchi, who expressed his opinion by lowering the prophetic

- 4) The Book, Life Sketches of James White and Ellen G. White, Ellen G. White, 1888. This book is about the sanders of Ellen's life in her sermons with James White. The writer took this book to reveal the life history of the journey of Ellen White and James.
- 5) The Book, *A Sketch of the Christian Experience and View of Ellen G. White*, Ellen G. White Estate, 2010. This book has been written to tell others about the visions and instruction given to them by God. The writer would take this book as a foundation to unveil an Ellen White's vision along with her spiritual experience.
- 6) The Book, Berbagai Amanat Kepada Orang-orang Muda, Ellen G. White, 2014. This book is about Ellen G. White's credentials to the younger generation is a translated book from the Message to Young People by Ellen G. White herself. to prophesy to some extent. God's Word in the Bible says that prophecy is not limited by the "Prophet, Priest, and King" office.¹⁹ Everyone can be called a prophet in a certain level. However this title is of course to people who believe in Jesus Christ.²⁰

Some reasons why the Seventh-day Adventists are referred to God as the remnant people, cause they believe in the message given to Ellen G. White as Spirit of Prophecy. While in Christian, the meaning of the Spirit of Prophecy it is the will of God revealed to his church through the prophetic channels or prophets of the Bible,²¹like the inspired Word of God through His spirit to the prophets. Many Christians reject the Adventist prophetic and perceived as heretical prophets.

This thesis, the entitled "The Prophecy of Ellen G. White According to Catholic Church View" to express the problem between the Catholic Church and Adventists for the straightening of the dispute that occurred. Then how about the prophecy that Ellen White that was contributed to the Adventist congregation which so far is considered to deviate from Christianity. If that's a fact, then how about the opinion of the Adventist congregation and Catholic on this matter. Therefore the writers want to clarify the answersto differences of opinion to unite the intersection of this discussion.

To clarify the result of two different opinions, the writer in this discussion uses two approaches. The first is the Phenomenology Approach,²² in respect of the total raised by the writer to examine the subject matter of the

G. Research Method
