Untuk menunjukkan bunyi hidup panjang (*madd*), caranya adalah dengan menuliskan coretan horizontal (*macron*) di atas huruf, seperti ā, ī, 69 dan ū). Contoh: al-Islām (الإسلام), al-Ḥadīth (الحديث), al-Mā'ūn (الماعون). Bunyi hidup dobel (diphthong) Arab ditransliterasikan dengan menggabungkan dua huruf “ay” dan “aw”, seperti *khayr* (خير) dan *khawf* (خوف). Kata yang berakhiran *tā' marbūṭah* (ة) dan berfungsi sebagai sifat (*modifier*) atau *muḍāf ilayh* ditransliterasikan dengan “ah”, seperti *dirāsah Islāmiyyah* (دراسة إسلامية), sedangkan yang berfungsi sebagai *muḍāf* ditransliterasikan dengan “at”, seperti *dirāsah al-Qur'ān*
