CHAPTER I

INTRODUCTION

use various devices to convey educational messages to students through vision and hearing to avoid visual aids alone, which may still be done if only using online media. In his attempt to use media as a tool, Edgar Dale classified experiences into levels from the most concrete or precise to the most abstract.⁶ Therefore, in this case the teacher can master and understand learning media, so that students can be more excited, have passion in teaching and learning activities, which in turn allows students to achieve better learning outcomes.

One way to use school facilities effectively is to improve the development of learning media, so that students can easily understand the material taught by teachers. Therefore, educators must utilize school facilities that are already available, such as computer labs and others. The development of technology cannot be prevented. Therefore, educators must make the best use of it to create learning innovations that suit the needs of students. One way to do this is to use the Canva application as a technology-based learning media. Teachers can use this application online to create interesting learning materials, especially in the context of Fiqh lessons.⁷

One of the strategies that can attract the attention of students and be applied by a teacher such as interactive multimedia learning media based on the Canva application. The researcher used the Canva application to be used as learning media with the theory of Richard E. Mayer because according to Mayer, learning is more effective when students are given materials that integrate text, images, video, and audio. Canva supports this principle by providing tools to create engaging multimedia content and supports visual-based learning. then the theory of Jean Pigeot and Lev Vygotsky because according to them, Canva allows students or teachers to create interactive and creative learning materials, which supports a constructivist approach

where students learn by building their own understanding through creative media.

This learning media can be applied by educators when explaining material in the learning process so that students focus and are able to receive lessons well. Through the use of Canva applications, teachers can teach knowledge, foster creativity, and develop student skills. In addition, this media can also be utilised in various other aspects of life.⁸ There is a relationship between Canva application and learning media because of the ease of making learning media, increasing creativity and skills, effectiveness in learning, use on various platforms, and use in various subjects.⁹ MTsN is Madrasah Tsanawiyah is the basic level of formal education in Indonesia, equivalent to junior high school, which the Ministry of Religious Affairs manages. This madrasah tsanawiyah education is taken within 3 years, starting from 7th grade to 9th grade.

Based on the results of observation with Fiqh subject teacher conducted by a researcher on April 2024, at MTsN 9 Bantul, the teacher stated that he still used the lecture method, which resulted in the delivery of material tending to be boring. Then, the atmosphere in the classroom sometimes feels monotonous, which causes students to feel discouraged and sleepy. The teacher also explained the lack of use of learning media, due to the factor of teachers who are old and not too familiar with technology. Several grade 8 students' grades in Fiqh subjects still do not meet the KKM (Minimum Completeness Criteria). The KKM (Minimum Completeness Criteria) in Fiqh lessons in grade 8 is 79, nearly 50% of the students have not yet reached the target score.

Observations of classroom activities revealed several challenges affecting student learning outcomes in Fiqh, including: 1) Low Student Engagement: Students often find the learning environment monotonous, especially in Fiqh subject, leading to decreased engagement and interest. 2) Limited Teacher Creativity, especially in choosing models and approaches to students, 3) Students lack of concentration in PAI lessons.

By looking at this fact, the researcher took the initiative to provide a solution to selecting learning strategies. Therefore, the author believes that selecting learning strategies for interactive multimedia learning media based on the Canva application will be very effective and fun as an approach for students in the learning process. The author believes that this learning media can help students restore concentration while learning so that increased learning outcomes can be achieved.

Based on the problems in the background, it encourages the author to apply application-based interactive multimedia learning media in the learning process. Hopefully, it can stimulate students to have more fun in their learning activities.
