CHAPTER I

Introduction

A. Background of Study

Celibacy is singleness or celibacy, and not marrying. In a sense, it is an offering of self based on complete love that is specifically related to the shepherding of souls in order to unite with the purity of God. Celibacy is a form of sacrifice and obedience to the religious vows that are at the heart of the vocation to the Catholic priesthood. Celibacy also plays a very important role in enhancing the spiritual life and in the spiritual journey.

Celibacy is one of the fundamental commitments in the life of a Catholic priest who aims to devote himself fully to God and the people. This commitment has been an integral part of the Catholic Church for centuries, but in the modern context, the practice faces various challenges. Social and cultural changes that are increasingly open to individual freedom as well as the psychological demands faced by priests make celibacy a vocation that requires spiritual and mental fortitude. ² Therefore, this study aims to analyze the influence of celibacy on improving the spirituality of priests in the Catholic Church of Paroki Santo Mateus, Pare, and identify the strategies they use in overcoming these challenges.

In the development of the teachings of the Catholic Church, celibacy is not only considered as an obligation to receive the sacrament of priesthood, but also as a special gift from God. For those who practice celibacy, it is also a surrender to the Church.³ Thus, the Catholic Church that will be the source of this research is Catholic Church of Paroki Santo Mateus, Pare, which is the only and largest Roman Catholic Church in Pare. The priests in the church make celibacy a means to get closer to God based on sincere service and love. As for the uniqueness of the church, there are carvings of buildings and a statue of Jesus in front of the church. There are several things that distinguish this church from others, namely, in the implementation of any ceremony is not accompanied by musical instruments so as to emphasize the sacredness of the ceremony. And this church does not have a baptismal pool like churches in general. The congregation in this church is approximately 500 people.

Celibacy not only focuses on theological aspects, but also integrates psychological and sociological perspectives. With this approach, it can provide a broader understanding of how celibacy can increase closeness to God, while presenting emotional challenges that must be managed by pastors. In addition, this study also highlights how church community and social support can play a role in helping pastors live out their celibate commitment more stably.

In addition, this study presents new insights into the strategies used by pastors in dealing with the challenges of celibacy. Some of the strategies found in this study include spiritual reflection, active involvement in the church community, as well as the development of positive personal activities such as reading, writing and exercise. As such, this study not only provides theoretical insights, but also offers practical solutions that pastors can apply in better living out their commitment.⁵

The main contribution of this research is the development of concrete strategies for the Church to support priests in their celibate life. This research provides the basis for a more systematic pastoral approach in accompanying priests, including in terms of spiritual formation and emotional well-being. The results of this study are expected to serve as a reference for the Church in designing more effective programs to maintain the spiritual and mental balance of priests, so that they can carry out their ministry more optimally and meaningfully.⁶

Thus, the author wants to know about the meaning of celibacy itself, as well as explore further how celibacy can affect the improvement of the spiritual life of priests in the Catholic Church of Paroki Santo Mateus, Pare. In addition, the author wants to know the challenges and ways to overcome the problems faced by priests in carrying out the celibate life.

This study employs a of qualitative research data collection method using interviews and documentation. After reviewing the study, this study will discuss the influence of improving the spiritual life of pastors and their role in the Catholic Church of Paroki Santo Mateus, Pare.

To date, the researcher has not found any scientific paper specifically discussing Celibate Life and its Influence on Enhancing the Spiritual Life of the pastor. The primary distinction of this study from previous research is that there is a special interest in further exploring how celibate lives and its influence in improving the spiritual life of pastors in the Catholic Church of Paroki Santo Mateus, whether there are challenges and obstacles in carrying out the celibate life. Additionally, it will explore how these challenges can be overcome in the practice of celibacy.

F. Theoretical Framework

Celibacy is one of the main commitments undertaken by priests in the Catholic Church as a form of total devotion to God and the people. In practice, celibacy is not only related to theological aspects but also has

psychological and social dimensions that affect the spiritual life of priests.¹² Each individual has a different way of understanding and living their religious beliefs and teachings, including in living a celibate life. Therefore, it is important to examine how celibacy affects the spirituality of priests, especially in the Catholic Church of St. Mateus Parish, Pare, and how they deal with the various challenges that arise in living this commitment.

In conducting this study, the researcher Aims to employs a psychological approach to understand how individuals perceive and relate their behavior related to their religious experiences. Similarly, how humans reach for beliefs or religions to get closer to their God will be increasingly diverse according to their level of thinking.¹³

Thus, this research will be discussed in several ways, first it will explore the general knowledge of celibacy in Catholic Christianity. The second is related to the influence of celibate on the improvement of the spiritual life of the pastor in the Catholic Church of St. Mateus Parish, Pare. inally, it will discuss the challenges and ways to overcome in living celibacy.

G. Methods of Research

Research methods are scientific steps or procedures used by researchers in seeking data to meet their research objectives, arranged in the form of data collection and data analysis. ¹⁴ The research is carried out to make it easier for researchers to understand and explore what they will research. The series of research activities is to determine the type and method of approach, know the data collection techniques, and analyze the data to be researched. Moreover, certain steps in this series must be performed sequentially, one at a time.

1. Type of Research

To establish the truth, evidence based on valid facts is needed. Therefore, it is important to conduct research known as scientific research. This research employs a type of *grounded research* or field research that aims to study all conditions in the field intensively. The research method employed a qualitative method because qualitative studies emphasize field realities over the researcher's subjective perspectives. ¹⁵ The descriptive method of analysis was used to describe celibate life and its influence on

3. Data Collection Techniques

The data collection techniques that will be used in the research here as follows: *First*, in-depth interviews are structured to obtain information orally through questions and answers related to celibacy and its influence on the spiritual enhancement of the pastor. *Second*, direct observation, namely by observing the activities carried out by the pastor in the Church Catholic Parish of Saint Matthias, Pare. *Third*, the collection of documents related to the church to obtain information and archives to be analyzed.¹⁸ Then the researcher will explain the methods used, namely:

a. Descriptive Method

Descriptive method is a method used to describe or describe completely about several variables concerned in a particular phenomenon or reality.¹⁹ Researchers use this method to describe the meaning of Celibacy.

b. Analysis method

Analysis is an activity carried out by researchers after collecting data and then processed in such a way as to find conclusions.²⁰ Researchers use
